1.Terms of Reference

1.1 Overview

The Government Pensions Administration Agency (GPAA) administers funds on behalf of the Government Employee Pension Fund (GEPF) and National Treasury (NT) through Service Level Agreements between the parties. The GPAA as a component of Government accounts to the Minister of Finance as the Executive Authority and to National Treasury in respect of the non-contributory Funds. The National Treasury Contributory Fund has a number of Acts, statues and agreements and a total membership of about pensioner and beneficiaries. The GPAA manages a number of Funds and derives its mandate from various Acts and Statutes as well as Resolutions of the PSCBC.

In terms of the Service Level Agreement signed with National Treasury, the GPAA has the following sub-programmes which form the core delivery vehicles:

- Military Pensions and Medical Accounts
- Special Pensions
- Post-Retirement Medical Subsidies
- Injury on Duty and
- VIP Pensions.

This document outlines the scope of work and terms of reference for the appointment of an appropriately experienced Medical Claims Administration (MCA) service provider to manage and process medical claims invoices for Injury on Duty (IOD) and Military Pensions Medical Accounts.

1.2 Service of administration

Military Pensions (MP) and Injury on Duty (IOD) seek the services of a Medical Claims Administration (MCA) service provider with (MCA) experience in the processing of medical invoice administration, for IOD claimants and Military pensioners.

The current payment process is paper based and manual, and as such it is open to errors in payments, internal and external fraud and, it is difficult to monitor the reasonability and the need for the medical services being paid for.

(See attached "AS IS" processes)

1.3 Scope of Work

The MCA's responsibilities shall include, but will not limited to the following:

- **1.3.1** Validating beneficiaries who claim for medical treatment;
- 1.3.2 Validating and reviewing all medical claims invoices from all active

registered medical service providers i.e. GPs, Specialists,

Hospitals, Allied health professionals, and all Health Institutions or

Health Service Providers who are registered to render clinically

appropriate medical services to all beneficiaries;

- **1.3.3** Developing and maintaining a tariff file against which claims will be paid according to COIDA tarrifs as amended on prosthesis
- **1.3.4** Document and Knowledge Management
- 1.3.5 Fraud and Risk Management
- 1.3.6 Reporting and Accounting; and
- 1.3.7 Beneficiary and Healthcare Provider Call Centre Support

1.4 Deliverables

- **1.4.1** Monitor the treatment programs recommended for members by doctors, specialists and other health care providers by reviewing all reports prepared by them and maintaining contact with these providers as may be appropriate;
- **1.4.2** Maintain a current estimate of expected total cost of various claim, and provide for reserve calculation tracking (including initial reserve establishment and all subsequent changes) within the claim
- **1.4.3** Provide narrative reports of medical invoices and settlement requests as requested by the Military Pensions.
- **1.4.4** Provide an interface with a medical invoice data switching service and/or have the ability to receive invoices directly from medical service providers;

- **1.4.5** Prepare thoroughly documented notes to all claim files with respect to an initial summary description of hospital events, expected settlement figures, admission and discharge dates, telephone conversations, etc.
- **1.4.6** Provide direct access or real-time internet based access to GPAA that includes all required software. The on-line access shall include, but is not limited to, access by claim to the claim historical data, supervisory and assessor note screen, all payment detail, including short payments and non-payments, and notes on system confirming file review frequency. Preferably the on-line access shall provide all documentation of a claim file in a paperless environment and allow the GPAA the ability to run management reports as needed;
- **1.4.7** Provide real time access to the medical service provider with the sole purpose of allowing the provider to view the status of his claim.
- **1.4.8** Provide in an electronic format any other additional information, analysis, reports and services as requested by the Military Pensions unit.
- **1.4.9** Meet, at least monthly, with the Military Pensions unit to review claims settlements, clinical protocols and strategy.
- **1.4.10** The MCA agrees that data contained on tapes, discs, files, batch files, and other records pertinent to the MCA's services provided to and on behalf of Military Pension unit, are the property of the GPAA and must be enabled for separate retrieval and distribution. The GPAA must provide for the physical security of all such records. The MCA shall provide for transfer of records currently in off-site storage at a cost agreed to with the GPAA. The MCA shall provide the GPAA with written procedures documenting its security and off-site storage of all such records and such documentation shall become an attachment of the Agreement.
- **1.4.11** Transaction data shall be maintained for seven years after the claim is closed. Summary data shall be maintained indefinitely. All data, including medical, financial, and personnel information reviewed and collected in connection with the Agreement shall be held in strict confidence and shall not be released, disclosed, or published by the MCA without the written consent of the GPAA, except to the GPAA or others required to provide a service under the Agreement.

- **1.4.12** The MCA shall provide the Military Pensions unit with its written Business Continuity of Operations Plan and such documentation shall become an attachment of the Agreement.
- **1.4.13** The MCA agrees that Military Pensions shall have the right to audit all records maintained by the MCA relative to the MCA's performance under the Agreement. The Military Pensions unit shall also maintain the right to perform financial, performance and other special audits on such records maintained by the MCA during regular business hours throughout the Agreement period. The MCA agrees that confidential information, including, but not limited to medical and other pertinent information relative to claims of the Military Pensions unit, shall not be disclosed to any person or organisation for any purpose without the written consent of MCA, except to Military Pensions unit or others required to provide a service under the Agreement.
- 1.4.14 The MCA's administrative office shall, at a minimum, be open for business, Monday through Friday, each week of the year excluding legal holidays or closure due to causes beyond the reasonable control of the MCA.
- **1.4.15** Finalised files to be sent to the GPAA for storage or archiving as per GPAA policy.
- 1.4.16 The MCA is to agree to an Independent audit (when required)
- **1.4.17** The MCA shall consult with and assist Military Pensions Unit in the establishment and coordination of necessary procedures and practices to meet any applicable legislative requirements and needs of Military Pensions Unit
- **1.4.18** The MCA shall cooperate and assist the GPAA in the event a Risk Management Information System is established by Military Pensions Unit, in the transferring of data and all necessary information needed by the MIS system and vendor.
- 1.4.19 The MCA shall participate in the training of Military Pensions unit personnel who are directly or indirectly involved in the processing of medical claims throughout the term of the Agreement. This training includes, but is not limited to, orientation of their personnel with regard to proper claims procedures, statutory requirements, and other matters necessary for the administration of the program.
- **1.4.20** The MCA shall work closely with Military Pensions Unit including meeting with management as requested for the purpose of furnishing requested information.

- 1.4.21 Upon termination of the agreement, the MCA shall cooperate with theMilitary Pensions unit during the transition of the business to the new modernized GPAA IT system. Upon request from Military Pensions unit, the MCA shall provide all information maintained by the MCA in a time frame approved by the Military Pensions unit with no additional fees. Information provided via tape shall be in a format approved by the Military Pensions unit and shall include, but not be limited to file layouts and legends. The MCA shall provide such explanation of the information provided as to facilitate a smooth transition.
- **1.4.22** The MCA shall load and maintain all Military Pensions unit claims data for all claims, whether open or closed.
- **1.4.23** The MCA shall process all run-out claims for 180 days following the termination of the Agreement, if requested in writing by the Military Pensions unit, at the same fee as the last year of the Agreement.
- **1.4.24** The MCA shall provide direct lines to the staff dedicated to handling Military Pension's claims for communication with the Military Pensions unit staff. The Military Pensions unit will be responsible for all communication with all stakeholders (employees, employers, medical service providers and pensioners).
- **1.4.25** The service provider is to provide an end-to-end administration solution that covers all the deliverables stipulated in the Scope of work at 1.3 above. Deliverables must be in accordance with best practice. The Proposal is to be presented to GPAA and must include an implementation plan.

1.5 Required Competencies

At least 5 to 10 years or more experience as a medical claims administrator

1.6 Duration of Contract

The appointment of the MCA will be for a period of 3 (three) years from the agreed date with an option to renew for a further 2 (two) years.

1.7 Contractual Obligations

Familiarize yourself with general conditions of contracting attach in the BID pack.

1.8 Proposed services approach

The service provider's approach to providing the service described in this RFP must meet or exceed the requirements laid down by this RFP.

Examples of the areas which will be considered as part of these criteria, include the following:

- **1.8.1** Overall understanding of the service provider's Medical claims administration services.
- **1.8.2** Implementation planning and approach.
- **1.8.3** Fit of service provider's existing standards, procedures and operating capabilities with the requirements of the GPAA.
- **1.8.4** Comprehensiveness and recommended approach to document management
- **1.8.5** Adequacy of the service provider's infrastructure, physical and financial resources and expertise for supporting the GPAA 'requirements.
- **1.8.6** The service provider's demonstrated ability to meet all turnaround times.
- **1.8.7** The service provider's demonstrated physical and electronic security.
- **1.8.8** The service provider's demonstrated audit standards and procedures.
- **1.8.9** The service provider's demonstrated ability to maintain a database according to the GPAA's requirements.
- **1.8.10** The service provider's demonstrated ability to maintain document management systems according to the GPAA's requirements.
- **1.8.11** The service provider's demonstrated ability to develop detailed assessment reports and projects reporting.

1.9 General business and financial strength.

1.9.1 The general business and financial strength of the service providers responding to this RFP is of crucial importance. Therefore, service providers must demonstrate to the satisfaction of the GPAA its general business and financial strength. For this purpose the service provider(s) must provide audited financial statements, including balance sheets and income statements for the past three years. The service provider(s) should describe the last three year's trends in revenues, employees, profitability and investments. The service provider(s) must also list its current outstanding contractual liabilities and obligations.

1.9.2 The successful service provide(s) should also be able to demonstrate a commitment to the development, implementation and maintenance of medical claims administration systems as an ongoing line of business through the last three years and staff that are directly committed to it. The length of time the service provider has been in business of development, implementation and maintenance of medical claims administration systems as well as overall business experience will be considered.

1.10 Current and past customer references

The service provider(s) must, to the satisfaction of the GPAA, demonstrate that it has the ability to implement and maintain medical claims administration systems. For this purpose the service provider must provide information and references for current and past implementation and maintenance of the medical claims administration services. The size, industry and products of these customers must be described as well as the types of services provided. The date of service to each customer should be included as well as whether or not the service provider was the primary contractor or subcontractor. If a subcontractor, the service provide information on the portion of the service (s) that they were responsible for as subcontractors. The service provider should include a summary of all recent reviews by its customers and should note the number and type of non-compliance with performance levels that were identified.

1.11 Site visits to service provider's operations

The GPAA may conduct site visits to the preferred service provider's operations either at the service provider's site or at current customer sites. These visits will be considered as part of the service provider's capability to provide the service levels, quality of service and operations necessary to support the GPAA's requirements. This will / could include live link-ups with the service provider's site(s).

1.12 Presentations

- 1.12.1 Shortlisted service providers shall be expected to make a presentation of a maximum of 30 minutes to the Bid Evaluation Committee. The presentation should be focused solely on the requirements of the RFP. The service provider should also be able to answer questions related to any aspect related to the bid proposal.
 - **1.12.2** The GPAA will notify the service provider of the date, time and venue where the presentation must be done (Service providers may not stay overnight at the same venue where the evaluation of the bids will take place)

1.13 Formats for response to bid

1.13.1 Service providers must prepare and package their bid proposals and all related documents in accordance with the following framework. A service provider's proposal must be clear, factual and to the point. Brochures and other marketing material as a response to this RFP will not be accepted. All matters addressed in the RFP must be addressed. Should a service provider wish to provide additional information, the said information must be appended to the specific section of the proposal to which it pertains and/or be referred to and included in a file of annexures.

1.13.2 Service provider Background and History.

- 1.13.2.1 Date that the firm was founded
- 1.13.2.2 Historical background
- 1.13.2.3 Revenue history of the firm
- **1.13.2.4** Certificate of Financial Soundness including the last three years audit financial statements.
- **1.13.2.5** Services provided by the service provider.
- **1.13.2.6** Applicable CV's.

1.14 Claims administration experience

- **1.14.1** Description of the Medical Claims Administration experience rendered to current customers.
- **1.14.2.1** List of current customers and their locations.
- **1.14.2.2** List of contacts within these customers.
- **1.14.2.3** Notation as to which customers would be available for site visits / reference details.
- 1.14.2.4 Public Sector clients
- 1.14.2.5 Companies with geographically dispersed locations
- **1.14.2.6** The size, industry and products of these customers must be described as well as the types of services provided.
- **1.14.2.7** The date of service to each customer

1.15 Service provider capabilities

- **1.15.1** Description of experience in the Medical claims administration industry.
- **1.15.2** Description of experience in the Public Sector (within this context it refers to the three spheres of Government, i.e. National, provincial and local authorities (municipalities) and the Medical claims administration industry, both nationally and internationally (if applicable).
- **1.15.3** Description of current infrastructures, including, but not limited to staffing numbers.
- **1.15.4** Description of current medical schemes who are presently clients of the service providers
- **1.15.5** Expertise and experience in implementing and maintaining medical client administration systems.
- 1.15.6 Change management and project management skills and practices
- **1.15.7** Formal methodologies employed (if any)
- **1.15.8** Expertise in legislative and regulatory framework within which the Public Service functions, e.g. the Public Finance Management Act, the Public Service Act, etc.
- 1.16 Response to the implementation and application of the Claims Administration Services.

The primary requirements of this part of the service provider's proposal is that it should demonstrate possession of the required resources, e.g. human and financial to provide and maintain medical claims administration services to Medical Aid Schemes or Employers

- a) The procedure that it will apply to achieve the required service levels. The procedural descriptions should cover all the aspects of the service provider's responsibilities;
- b) A description of staff available claims administrators to provide the services and render support when required;
- A description of its document management system, with due consideration of the needs identified in this RFP;
- d) A description of the help desk to be offered;
- e) A description of any additions or amendments to be incorporated into the GPAA contact (draft service level agreement (s); and
- f) Any physical infrastructure e.g. IT services, licenses, geographical disbursed offices, etc. to fulfil the tasks.

1.17 Response to the implementation ability.

In this section, the service provider should provide enough information about the service provider's approach to the implementation task to permit the GPAA to make a valid assessment of the service provider's qualifications and/ or abilities. At a minimum, the following information should be provided:

- a) The ability of the service provider to commence with implementation within three months of appointment.
- b) A complete description of the services that the service provider would label as implementation services.
- c) An implementation work plan including detailed activities, timing and responsibilities.
- d) The proposed staff dedicated to the implementation process.
- e) A description of the service provider's experience in performing implementation related services, i.e. previous implementations including

the names and details of clients for whom these services have been performed.

1.18 Financial Proposal- Submit separately from the Proposal

The Financial Proposal should be per percentage (%) of total invoices processed ready for payment. The following actual expenditures were incurred for the periods 2013 -2016:

- 2013/2014 R24,2m
- 2014/2015 R18,7m
- 2015/2016 R10,4m

- 1.5. **"Countervailing duties"** are imposed in cases where an enterprise abroad is subsidized by its GPAA and encouraged to market its products internationally.
- 1.6. **"Country of origin**" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. **"Day**" means calendar day.
- 1.8. **"Delivery**" means delivery in compliance of the conditions of the contract or order.
- 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10. **"Delivery into consignees store or to his site**" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. **"Dumping"** occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. **"Force majeure**" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13. **"Fraudulent practice**" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14. **"GCC**" means the General Conditions of Contract.
- 1.15. **"Goods**" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract

- 1.16. **"Imported content**" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17. **"Local content**" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18. **"Manufacture**" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19. **"Order**" means an employee written order issued for the supply of goods for works or the rendering of a service.
- 1.20. **"Project site**," where applicable, means the place indicated in bidding documents.
- 1.21. **"Purchaser**" means the organization purchasing the goods.
- 1.22. **"Republic**" means the Republic of South Africa.
- 1.23. **"SCC**" means the Special Conditions of Contract.
- 1.24. **"Services"** means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25. "Written" or "in writing" means handwritten in ink or any form of 96 electronic or mechanical writing.

2. APPLICATION

- 2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. GENERAL

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2. With certain exceptions, invitations to bid are only published in the State Tender Bulletin. The State Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.employee.gov.za.

4. STANDARDS

4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. USE OF CONTRACT DOCUMENTS AND INFORMATION; INSPECTION

- 5.1. The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2. The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3. 3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4. The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. PATENT RIGHTS

6.1. The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. PERFORMANCE

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance **security** of the amount specified in SCC.
- 7.2. The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3. The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - 7.3.1. a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - 7.3.2. a cashier's or certified cheque
- 7.4. The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. INSPECTIONS, TESTS AND ANALYSES

- 8.1. All pre-bidding testing will be for the account of the bidder.
- 8.2. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.

- 8.3. If there is no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing Energy Board concerned.
- 8.4. If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5. Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7. Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. PACKING

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2. The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. DELIVERY OF DOCUMENTS

- 10.1. Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2. Documents to be submitted by the supplier are specified in SCC.

11. INSURANCE

11.1. The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. TRANSPORTATION

12.1. Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. INCIDENTAL SERVICES

- 13.1. The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
 - a performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - b.furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - c.furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - d.performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - e.training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. SPARE PARTS

- 14.1. As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier: a.such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - b.in the event of termination of production of the spare parts:
 - i. Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - ii. Following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. WARRANTY

- 15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

- 15.5. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.6. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. PAYMENT

- 16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
- 16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4. Payment will be made in Rand unless otherwise stipulated in SCC.

17. PRICES

17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. CONTRACT AMENDMENTS

18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. ASSIGNMENT

19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. SUBCONTRACTS

20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. DELAYS IN THE SUPPLIERS PERFORMANCE

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, it's likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.

- 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or local authorities.
- 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6. Upon any delay beyond the delivery period in the case of supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. PENALTIES

22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. TERMINATION FOR DEFAULT

- 23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - a.if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - b.if the Supplier fails to perform any other obligation(s) under the contract; or
 - c.if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

24. ANTI-DUMPING AND COUNTERVAILING DUTIES AND RIGHTS

24.1. When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he

delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. FORCE MAJEURE

- 25.1. Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. TERMINATION FOR INSOLVENCY

26.1. The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. SETTLEMENT OF DISPUTES

- 27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4. Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5. Notwithstanding any reference to mediation and/or court proceedings herein, a.the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 b the purchaser shall now the supplier any menice due the supplier.

b.the purchaser shall pay the supplier any monies due the supplier.

27.6. Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6.

28. LIMITATION OF LIABILITY

28.1. The supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser.

28.2. The aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. GOVERNING LANGUAGE

29.1. The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. APPLICABLE LAW

30.1. The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

31. NOTICES

- 31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. TAXES AND DUTIES

- 32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3. No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid, GPAA must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
